

## **Journal of Tropical Forest Research (JTFR)**

JTFR is a peer-reviewed journal, publishing original, invited and review papers on tropical forest research. The journal aims to provide a platform for exchange and distribution of the knowledge and cutting-edge research in the field of natural resource science and management to academicians, scientists and researchers. The journal accepts a varied array of manuscripts on forest ecology, forest management, watershed management, silviculture, biological diversity, systematic relationships, geographic distribution, morphology, utilization and physiology of flora and fauna, and climate change, etc. The study of the existing or emerging problems of natural forest resources and environments in Thailand and Southeast Asia and the creation of novel knowledge and/or recommendations of mitigation measures for sustainable development policies are emphasized.

### **Peer Review Process**

All submitted manuscripts are screened by the Editor for importance, substance, appropriateness for the journal, general scientific quality, and amount of new information provided. Those failing to meet current standards are rejected without further review. Those meeting these initial standards are sent to expert referees for peer review. **Peer-review process** will be performed by **at least double-blind experts**, which means that both the reviewer and author identities are concealed from the reviewers, and vice versa, throughout the review process. Reviewer comments are reviewed by Editor and he/she, often after allowing the author to make changes in response to the comments, advises the Scientific Editor to either accept or reject the manuscript. The Scientific Editor informs the author of the final decision. The review process ordinarily is completed within 3 months. If the process is delayed beyond that point, authors will be notified.

### **Publication Frequency**

Journal of Tropical Forest Research is published bi-annually (June and December) by the Forestry Research Center, Faculty of Forestry, Kasetsart University.

### **Open Access Policy**

This journal provides immediate open access to its content on the principle that making research freely available to the public supports a greater national and international exchange of knowledge.

## **Publication Ethics**

Journal of Tropical Forest Research follows closely a set of guidelines and recommendations published by Committee on Publication Ethics (COPE) (<https://publicationethics.org/>). All parties involved in the publishing process including editors, reviewers, authors and others are required to be familiar with them and to the publication ethics as described below.

### **Authors**

Authors should present the results accurately, clearly and honestly without fabrication, inappropriate data manipulation, commercial or non-commercial conflict of interest, ensuring their actual involvement in the work and sufficient contribution to the scientific results and findings that could be corroborated or verified by others. Additionally, in research where animal participants or use of biological materials are involved, authors are required to provide information about ethical aspects of the research.

Regarding the submission, the manuscript must not be previously published in another journal or simultaneously submitted for publication elsewhere. Authors are expected to participate in the peer-review process and respond to the requirements of the Reviewers and Editors for the corrections and improvement of the manuscript to the best of their ability.

### **Reviewers**

The peer reviewers are expected to assist the editor and the editorial board in evaluating manuscripts based on content without any discrimination and presenting their feedback on the works in an accurate and clear manner. They must also ensure that all the information related to the manuscripts is kept confidential and must report to the Editor-in-Chief if they are aware of copyright infringement and plagiarism on the author's side.

The reviewers should declare or notify the Editor-in-Chief and withdraw from the review process if they do not have the required subject expertise to carry out the review. In the case that they are able to assess only a part of the manuscript, they are required to outline clearly the areas for which they have the relevant expertise.

### **Editors**

The final decision to accept or reject a manuscript for publication is made by Editors based on the paper's importance, originality and clarity, and the study's validity and its relevance to the remit of the journal who will ensure the confidentiality of the information or materials submitted by the authors, the protection of peer referees' identities, the transparency, fairness and punctuality of the peer review process, all of the information and materials will only be disclosed as appropriate to the author(s), reviewers and other editorial advisors.

**Publishing Ethics**

Journal editors should consider issuing an expression of concern if they receive inconclusive evidence of research or publication misconduct by the authors as well as promptly respond to possible misconduct, which can range from minor to serious breaches of the publication ethics, or inappropriate behavior of any parties involved in the publishing process including authors and reviewers.

Furthermore, inaccuracies, misleading texts or wrong explanations found in the published article must be corrected promptly by the author (s). The editors are willing to publish corrections, errata, clarifications and apologies if the need for doing so arises. All complaints will as well be seriously investigated by the editor regardless of who files the complaint.

The copyright of the published article is transferred to Journal of Tropical Forest Research, including without limitation, the right to publish the work in whole or in part in any and all forms of media, now or hereafter known, and effective if and when the article is accepted for publication, thus granting Journal of Tropical Forest Research all rights for the work so that both parties may be protected from the consequences of unauthorized use.
